It is always advisable, especially if the participant is pregnant, disabled in any way or recently suffered an illness, injury or impairment, to consult a physician before undertaking any

physical activity. Recreational programs/activities are intended to challenge and engage the physical, mental and emotional resources of each participant. Despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury when participating in any recreational program/activity. Understandably, not all hazards and dangers can be foreseen or avoided.

Hello All!

We expect to have another great year of Friends Forever Bowling! This letter contains the basic information for our bowling league and general policies. We bowl at Yorktown Lanes, located at 6218 Pearl Road in Parma Heights and the phone number is 440-886-5300. **We MUST have a signed membership application in order for an individual to participate in bowling. No exceptions. If a bowler shows up that does not have an application turned in, or it is not signed, he/she will NOT be permitted to bowl until the signed application is received.**

In case of extreme inclement weather or other emergencies, please call Yorktown Lanes at 440-886-5300, we will notify the bowling alley FIRST if bowling is cancelled. Notices will also be posted on our Facebook page at: facebook.com/friendsforeverinc/

Our 32-week bowling season starts **Saturday, September 9th, 2023. Please plan to arrive by 12:00 PM.** We plan to bowl every Saturday through April 13th, 2024. The cost is \$10 every week and the absence fee is \$2 per week. Bowling shoes, if needed, are included. You may pre-pay for the entire season (\$300) or on a month-to-month basis (\$10 for each Saturday in the month). Note that all bowling fees are separate from the membership fee of \$75. Please make **ALL** checks payable to: **FRIENDS FOREVER, INC.**

Please arrive by 12:00 PM every week. This allows time for check-in, getting shoes and getting settled at the assigned lane. **Practice starts at 12:15 and the scoring system will start promptly at 12:30 PM. If you are late, you will have to wait for the second game to start in order to bowl. We cannot stress that enough.** Every week we have over 100 bowlers that all need to be checked-in, get shoes and make their way to the assigned lane. If you plan on eating lunch at Yorktown Lanes, please take that into consideration and plan on arriving by 11:30 to order and eat your food **BEFORE** bowling starts. ***Please be courteous to Yorktown Lanes—NO OUTSIDE FOOD OR DRINKS IN THE BOWLING ALLEY. This means NO McDonald's, NO Subway, NO Burger King, NO DunkinDonuts, etc.*** We ask that you eat all outside food prior to entering the bowling alley. Scheduled, dietary restrictions are the only exceptions.

IMPORTANT NOTICE: Yorktown Lanes does have automatic scoring machines **HOWEVER we need a responsible person accompanying each bowler, EVERY week.** Knowing how to keep score is NOT required. Unless the bowler is providing his/her own transportation, **YOU MUST BE THERE TO HELP. This especially applies to ALL agency staff personnel. DO NOT DROP OFF YOUR BOWLER AND LEAVE OR SIT IN YOUR VEHICLE! ALL agency staff MUST sit at the lane where the client is bowling. Being able to “see” the client is not enough. Agency staff clustering together at tables away from the bowlers will be asked to move to the assigned lane. This is not free-time for staff members. Non-compliant staff will be reported to the respective agency and CCBDD SA's will be notified.** Every team needs someone to make sure the scoring machine is recording the correct score and the bowlers are going in the correct order.
